Financial framework

Resources currently allocated to the EU Trust Fund for Africa amount to approximately **EUR 4.6 billion** including more than **EUR 4.0 billion** from the European Development Fund (EDF) and EU financial instruments including DCI, ENI, HOME and ECHO funding. EU Member States and other donors (Switzerland and Norway) have contributed around **EUR 528 million**, of which **EUR 487** million have been paid so far.

As of 25 July 2019, **209 programmes** have been approved by the Operational Committees, including 5 cross-window programmes, for a total amount of **EUR 4007.1 million**, divided as follows:

- Horn of Africa EUR 1406.1 million (77 programmes)
- North of Africa EUR 647.7 million (26 programmes)

A total of **468 contracts** with implementers have been signed so far for a total of amount of approximately **EUR 2866 million**.
