The original results and main activities remain valid and unchanged, and are supplemented as follows:

## Result 4: Chad finalises the required legal framework for WAPIS and the system is sustainable

- **Activity 4.1**: Facilitate the adoption of the appropriate legal framework to collect, process and exchange electronic police data, and if needed provide technical assistance to the authorities
- **Activity 4.2:** Support Chad in the designing the legal status, and the roles and responsibilities of the entity managing WAPIS, and setting out the guidelines governing the use of the application
- **Activity 4.3:** Support Chad as regards the sustainability of the system, notably by allocating a budget line for the operation of WAPIS, and the maintenance of the datacentre and the IT equipment

### **Result 5: WAPIS in Chad is fully operational**

- Activity 5.1: Release of new versions of WAPIS based on users' feedback
- **Activity 5.2:** Update of the current DACORE (datacentre) and setup of a back-up datacentre, refurbished and equipped as needed
- Activity 5.3: Delivery of training sessions for users and mentoring
- **Activity 5.4:** Delivery of train-the-trainer sessions for relevant users
- **Activity 5.5:** Delivery of a training session for the DACORE staff on system and network administration

- Activity 5.6: Delivery of a training on security of data and protection of personal data
- **Activity 5.7:** Connection of relevant remote sites in the greater N'Djamena area (in particular the airport) to the datacentre. Number of remote sites to be connected is contingent on the cost per each connection as compared to budget
- **Activity 5.8**: Connection of relevant remote sites outside the capital (in particular border posts) to the datacentre. Number of remote sites to be connected is contingent on the cost per each connection as compared to budget
- **Activity 5.9:** Support to law enforcement agencies in the design and roll-out of procedures for collection and processing of data
- Activity 5.10: IT Technical assistance for the staff at the DACORE/ datacentre
- **Activity 5.11:** Integration of WAPIS training sessions into the curricula of the academies (police and gendarmerie)

## Result 6: If relevant, an AFIS is rolled out to complete the WAPIS system

- **Activity 6.1:** Purchase of a full AFIS solution
- **Activity 6.2:** Connect the AFIS to WAPIS and interface the systems in full so that they feed one another
- **Activity 6.3:** Purchase of the scanning equipment to feed the existing fingerprint forms into the AFIS
- Activity 6.4: Training and mentoring of staff in charge of scanning the fingerprint forms

## Result 7: WAPIS is connected to the INTERPOL databases through the NCB (National Central Bureau)

- **Activity 7.1:** Set out the technical and legal arrangements to allow exchange of data between WAPIS and the I 24-7 system through the NCB
- **Activity 7.2**: Connect WAPIS and the I 24-7 system

Result 8: Strategic partnerships are put in place with G5 Sahel and ECOWAS, so that exchange of data with other G5 Sahel Member states, on the one hand, and with ECOWAS member states, on the other, is feasible

- **Activity 8.1:** Carry out a legal and technical assessment of the police data produced by the members of ECOWAS and G5 Sahel
- **Activity 8.2:** If relevant, setting out the legal and technical arrangements that allow exchange of data between WAPIS Chad and counterparts
