

Figure 3: Free Movement¹





Figure 4: GCR IGAD

Figure 5: BRICK¹





Figure 6: IMPROVE-EU

Figure 7: LESP SLSP IFAD





Figure 8: Wadi El KU

Figure 9: SSRD1






Figure 10: Conflict Resolution South Sudan²



Figure 12: CRRF ET²



1.5. CHANGES AND CORRECTIONS

The tables below explain the differences in values reported in this report (S1 2024 report) and the previous EUTF MLS report (2023 annual report). Changes and corrections can be due to (i) indicator mapping revisions (when a project activity output and the associated data has been 'remapped' from one EUTF indicator to another), (ii) multiplier revisions (that is, adjustments to the formula used by the MLS to account for double counting of outputs), (iii) data corrections provided by the IP, (iv) data corrections made by the MLS team (for example, when unusual patterns are observed in a project's historical data and the IP is unable to provide an explanation in time for the report, the data points are temporarily removed from the database), (v) a project providing historical data that was not previously reported to the MLS, (vi) newly included projects in the MLS providing historical data retroactively and (vii) projects that have been retroactively included the MLS following improved communication or data collection procedures. Particularly significant changes or corrections are further explained in the footnotes below, and it is worth noting that the following projects made larger or multiple corrections to their data previously reported to the MLS.

- Erasmus+ (Regional) implemented a data verification exercise in 2024, resulting in numerous amendments to their historical data.
- HealthPro GOAL (Sudan) made retroactive corrections to their historical output data after undertaking a standard final review of their historical reporting, as requested by the MLS for all ending projects.
- COVID-19 Emergency Response WHO (Somalia) made multiple corrections to their data during the S1 2024 data collection, as it was discovered that not all historical data for the project had been reported to the MLS. Communication with the IP led to a clarification that a few activities had been misunderstood, resulting in a wider and extensive review together with the implementing partner. To that end, a new reporting template was created and data added retroactively in collaboration with the IP. This affected EUTF indicators 2.1 bis, 2.2, 2.7, 2.8, 2.9, 6.1 and 6.3.




1.6.1. NUMBER OF DIRECT JOBS CREATED OR SUPPORTED (EUTF INDICATOR 1.1)^{1,2}






1.6.2. Number of MSMEs created or supported (EUTF indicator 1.2)




1.6.3. Number of people assisted to develop income-generating activities (IGAs) (EUTF indicator 1.3)













1.6.9. Number of people receiving nutrition assistance (EUTF indicator 2.3)¹




1.6.10. Number of People Receiving food Security-Related Assistance (EUTF INDICATOR 2.4)









1.6.15. Number of People Having improved access to basic social benefits (Services and Transfers) (EUTF Indicator 2.9)




1.6.16. Number of migrants in transit, refugees/asylum seekers and IDPs protected and/or assisted (EUTF indicator 3.2)¹







1.6.18. Number of voluntary returns supported (EUTF indicator 3.4)¹



1.6.19. Number of returning migrants benefitting from post-arrival assistance (EUTF indicator 3.5)




1.6.20. Number of returning migrants benefitting from reintegration assistance (EUTF indicator 3.5 bis)¹





1.6.21. Number of institutions and non-state actors directly strengthened through capacity building or operational support on protection and migration management (EUTF indicator 3.6)¹





1.6.22. Number of individuals trained on migration management and protection (EUTF indicator 3.7)¹







1.6.24. Number of people benefitting from legal migration and mobility programmes (EUTF indicator 3.10)¹





1.6.25. Number of infrastructures supported to strengthen governance (EUTF indicator 4.1)¹



1.6.26. Number of items of equipment provided to strengthen governance (EUTF indicator 4.1 bis)





1.6.28. Number of people participating in conflict prevention and human rights activities (EUTF indicator 4.3)¹










1.6.33. Number of regional cooperation initiatives created, launched or supported (EUTF indicator 5.4)^{1,2}


